RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.


Enhancements in RTS POS 23.2

RRTS-9622 **Added Functionality to Invalidate Texas Registration When Out-of-State Ownership Evidence is Submitted**

Vehicles that have been titled out-of-state sometimes return to Texas and the Texas record reflects unexpired Texas registration. When RTS returns the Texas record with unexpired registration, the RTS user should select **Record Not Applicable**, which causes the registration to start over and charges the customer 12 months of registration fees from the current date and will not charge the registration transfer fee. Currently if a RTS user selects the Texas record with unexpired registration, this results in the customer not paying the required registration fees. This enhancement will ensure customers pay the required registration fees even if the RTS user selects the Texas record with unexpired registration in error.

This added functionality takes place when the RTS user selects one of the following on the **Ownership Evidence TTL011** screen.

- OUT-OF-STATE TITLE
- OUT-OF-STATE SALVAGE CERT
- O/S SALV CERT OF TITLE
- FOREIGN EVIDENCE





RRTS-31128 Added Functionality That Allows RTS Core Users to Add a Judge Remark to a Vehicle Record

Currently, federal, state, and county judges can obtain a judicial remark on their vehicle registration records when they have been issued Judge license plates. To allow the judicial remark to be added to vehicle registration records with general issue license plates, the following checkboxes were added to RTS Core:

- COUNTY JUDGE
- STATE JUDGE
- U.S. JUDGE


By selecting one of these checkboxes, the department has added the judicial remark on the vehicle record to notify law enforcement they are a judge.

RRTS-31338 Updated the IVTRS Application to Include Renewal Notice Delivery Options

The Electronic Renewal Notice Opt-in (ERNO) Phase 2 effort includes enhancements to Internet Vehicle Title and Registration Service (IVTRS) and Texas by Texas (TxT), which allows users to receive their vehicle registration notice electronically through Email or by standard mail.

Users select the Vehicle Registration Renewal Notice delivery option during the online vehicle registration renewal transaction. This update now allows the following options:

- Paperless - Email only
- Mail only
