Only checks, cashier's checks and money orders are accepted with mailed in applications. *Applications may be completed via TxPROS if paying by credit card or ACH and an active bond or letter of credit is on file as applicable.*

Miscellaneous Information

- Annual Timber Permit Bonds may be obtained through an Insurance or Surety Agent
- Irrevocable Standby Letters of Credit may be obtained through a financial institution
- Incomplete applications including inactive or no bond on file will be rejected
