The said vehicles are to used exclusively as indicated above by the said \_\_\_\_\_, for which authorization is made to operate under the provision of the Transportation Code, Chapter 623, Subchapter H, and amendments thereto.

The obligation of the Surety in connection with the operation of any vehicle is limited to \$1,000 per vehicle.

NOW, therefore, if the said \_\_\_\_\_ shall pay to the Texas Department of Transportation and to any municipality in which such vehicle is operated on a municipal street within the limits of this bond for any and all damages that may be sustained to any highway or a municipal street as above recited by virtue of the operation of the above named equipment under the provision of the law referred to above, beginning with the date of this bond and ending August 31, following; then this obligation is to be null and void, otherwise to remain in full force and virtue at law.
