The annual registration fee for the registration classifications listed above shall be based on the manufacturer's model year or weight in pounds, as the case might be, of the vehicle as follows:

6,001 LBS. AND OVER .....	\$25.00
<b>(irrespective of model year)</b>	PLUS .60 PER 100 POUNDS (CWT)

The weight of a vehicle in any of the above registration classifications shall be the weight generally accepted as its correct shipping weight plus one hundred pounds.
