

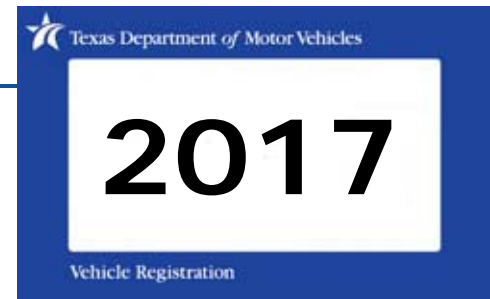

Background

- Processing & Handling Fee (P&H)
 - Replaces the \$1 Automation Fee and the \$1 Mail-In Fee
 - Automation Fee changes from \$1 to \$.50 on Jan. 1st
 - Authorized by statute and administrative rule:
 - [§217.185](#) Allocation of P&H Fee
 - [§217.168](#) Deputy Fee Amounts

- Compensation
 - \$1 from P&H fee (Jan. 2017 expirations & later)

P&H Fee Collected

Represents processing Nov. 1 – Dec. 31

- ▣ Renewals: Jan. 2017 expirations & later
- ▣ Private party title transfers: Jan. 2017 expirations - Reg. is current, within the window, vehicle registration is renewed
- ▣ Dealer title transfers: trans. date Jan. 1
- ▣ Temporary Permits: trans. date Jan. 1

P&H Exclusions

- P&H is not collected for the following transactions:
 - Replacement
 - Exchange (with no reg. fees collected)
 - Vehicle registered as Exempt
 - Receipts: Duplicate Receipt, Registration Correction, Inquiry Receipt, Inspection Fee Receipt
 - Reduced-Fee or No-Fee Military license plates

Processing and Handling Fee

The processing and handling fee listed in the amount due covers the cost of processing your vehicle registration. These costs include state and county services; printing of annual renewal notices; windshield or plate registration stickers; and other related services and materials.

If your vehicle is eligible to renew online at www.texas.gov, the total amount due will reflect a \$1.00 discount from the processing and handling fee.

January Changes

- Temporary Permits
 - P&H charged per permit (trans. date Jan. 1, 2017)
 - Retain entire P&H fee
 - No \$9 registration convenience fee

- Combination License Plates
 - Windshield Sticker Printed for 3/2018

- Registration and Title Convenience Fees
 - Registration: \$9 (when P&H is collected)
 - Title: up to \$20


