Dear Motor Vehicle Administrator:

The Pennsylvania Department of Transportation has recently revised Form MV-4, "Certificate of Title for a Vehicle". The edition date is now 10-05. A sample certificate of title is attached for your review.

The revised MV-4, "Certificate of Title for a Vehicle", includes the following changes:

- ◆ The statement, "An employees of a vehicle dealer who is licensed by the Pennsylvania State Board of Vehicle Manufacturers, Dealers and Salespersons, may verify a person's signature in lieu of notarization" was moved from the top to the side border on the reverse side of the title.
- ◆ A fourth reassignment section has been added to the reverse side of the certificate of title.

The security features remain the same. They are as follows:

- ◆ The border is still dark blue in color. The body of the form remains a shade of blue, blending into green, back into blue. The title paper contains fibers that glow under a black light. The color on the reverse side of the title is a light green.
- ◆ The border pattern has remained unchanged. The warning along the left margin within the left border and reads "Do Not Accept Document Without Verifying The Presence Of The Liberty Bell Watermark". The lower border has a break to allow for the title control number.
- ◆ The words "Commonwealth of Pennsylvania" and the warning printed in the bottom border remain the same.
- ◆ The state seal remains on the top ½ of the title.
- ◆ The background pattern remains the "Marbleized" look. The reverse side background is a "plain" look.
- ◆ A security feature behind the vehicle information located on the front of the title still remains.
- ◆ Still contains the Liberty Bell watermark and the security thread printed with the words "Commonwealth of Pennsylvania".
