



# Application for Authority to Dispose of a Motor Vehicle to a Demolisher

(Used for motor vehicles authorized to be towed by law enforcement)

## Information

This application can be used only if the abandoned motor vehicle was authorized to be towed by a law enforcement agency, is in the possession of the applicant, is over 8 years old and has no motor, is otherwise totally inoperable, or does not comply with all applicable air pollution emissions control related requirements under Transportation Code, Chapter 548, or the state's air quality state implementation plan. This application must be approved by the law enforcement agency authorizing the tow.

**Vehicle Identification Number:** Provide the number located on the body for any 1956 to current model year vehicle, the number located on the body for any 1932 to current model year Ford product, or the motor number for any 1955 and prior years (except Ford). Motorcycles typically use the number located on the frame; however, model years prior to 1971 may use a motor number. You should contact your local law enforcement auto theft unit if you need assistance in identifying the correct vehicle identification number.

**Application and Fee:** The fee is \$2.00 and should be in the form of a check or money order payable to the Texas Department of Motor Vehicles. **Do not send cash.** Credit/debit cards and temporary checks are not accepted. **Fees are non-refundable.** Mail this completed application with the fee to: **Texas Department Of Motor Vehicles, Vehicle Titles and Registration Division, ATTN: Title Control Systems, Austin, Texas 78779-0001.**
