This application can only be used if the motor vehicle is owned by the applicant, has been transferred to the applicant, or is abandoned and in the possession of the applicant or located on property owned by the applicant (see Page 2 for additional information).

Statement of Facts for Application

An application under this process must be for one of the following reasons. Mark the applicable reason, and provide a statement of facts, if applicable:

- The applicant listed is the recorded owner of the motor vehicle or has been transferred ownership.
- The vehicle is an abandoned motor vehicle (see Page 2) and in the possession of the applicant.
- The vehicle is an abandoned motor vehicle (see Page 2) and located on property owned by the applicant.

Application for Authority to Dispose of a Motor Vehicle to a Demolisher

Information for Applicants Who Are the Motor Vehicle Owners

Applicants with a motor vehicle last titled in Texas must surrender the Texas Certificate of Title if not lost or destroyed; however, the Texas Certificate of Title is not required if the department is able to verify the applicant is the owner in the department's system.

Applicants with a motor vehicle last titled outside of Texas must submit the certificate of title in their name.

Applicants who are not the recorded owner must submit a certificate of title or other valid ownership evidence showing the motor vehicle has been transferred to the applicant. Other valid ownership evidence includes, but is not limited to, a manufacturer's certificate of origin, registration receipt (if the motor vehicle is non-titled), or law enforcement auction sales receipt.

Information for Applicants Applying on Abandoned Motor Vehicles

A motor vehicle is abandoned if it:

- 1) is inoperable, is more than five years old, and has been left unattended on public property for more than 48 hours;
- 2) has remained illegally on public property for more than 48 hours;
- 3) has remained on private property without the consent of the owner or person in charge of the property for more than 48 hours;
- 4) has been left unattended on the right-of-way of a designated county, state, or federal highway for more than 48 hours;
- 5) has been left unattended for more than 24 hours on the right-of-way of a turnpike project constructed and maintained by the Texas Turnpike Authority division of the Texas Department of Transportation or a controlled access highway; or
- 6) is an impounded commercial motor vehicle at a vehicle storage facility and the delinquent administrative penalty has not been paid to the Texas Department of Public Safety by the 11th day after being impounded.

Department Notification Required

If an application is received for an abandoned motor vehicle, the department is required to send a notice to any owner(s) and lienholder(s) of the abandoned motor vehicle identified in the department's system. If no record is found in the department's system, the department is required to publish a notice on the department's website. The owner(s) or lienholder(s) have 20 days from the date the notice is mailed or published to claim the motor vehicle. If the department is not informed the vehicle has been claimed by the 20th day, the department will issue the Certificate of Authority to the applicant.

As a result of these requirements, issuance of a Certificate of Authority may take up to 30 days from the date the application is received by the department.

Claimed Abandoned Motor Vehicles

If the abandoned motor vehicle is claimed after this application has been submitted to the department, please contact the Vehicle Titles and Registration Division immediately at (512) 465-5659, option 1, to prevent the Certificate of Authority from being issued. However, the \$2.00 application fee is non-refundable.

Identifying the Correct Vehicle Identification Number

For any vehicle other than a Ford, provide the number located on the body for any 1956 to current model year vehicle and the motor number for any 1955 and prior year models. For Ford, provide the number located on the body for any 1932 to current model year and the motor number for any 1931 and prior year models. Motorcycles typically use the number located on the frame; however, model years prior to 1971 may use a motor number. You should contact your local law enforcement auto theft unit if you need assistance in identifying the correct vehicle identification number.

Odometer Reading Information

If the vehicle is less than 10 model years old (current year – 10), an odometer reading is required. If the odometer reading cannot be established, please indicate "1" and mark "Not Actual."

If the vehicle is 10 or more model years old, an odometer reading is not required; however, you must mark "EXEMPT."
