REGISTRATION AND TITLE SYSTEMS (RTS): RTS provides a uniform automated system for county tax offices to use in the registration and titling of vehicles. In FY 2019, there were approximately 3,123 workstations at 690 sites. There were 79,824,407 motor vehicle records (41,812,562 of which were archival records) in the automated file in FY 2019. Law enforcement made 66,802,555 system inquiries for an average of 127 requests per minute in FY 2019. The total collections from vehicle registration and title fees as well as motor vehicle sales tax was \$7,046,461,942 in FY 2019.

REGIONAL SERVICE CENTERS: Abilene, Amarillo, Austin, Beaumont, Corpus Christi, Dallas - Carrollton, El Paso, Fort Worth - Arlington, Houston, Longview, Lubbock, Odessa, Pharr, San Antonio, Waco and Wichita Falls.
