**PLAINTIFF'S ORIGINAL PETITION**

**Wherefore, Premises Considered,** Plaintiff prays that Defendant be served with citation herein and that this Court order the Defendant to return the manufacturer's certificate of origin and all other documents relative to the Vehicle to Plaintiff, or allow Plaintiff to obtain a duplicate manufacturer's certificate of origin if a certificate of title has been issued and for such other and further relief to which Plaintiff may be entitled.
