#### **Document Overview**

This document describes the latest software changes made to the Texas Department of Motor Vehicles (TxDMV) webDEALER software application.

#### Scope

The scope of this is to identify recent software changes to the webDEALER application as documented in the latest webDEALER User Guides. This document does not provide step-by-step instructions on how to use webDEALER.

#### Audience

The intended audience of this document are users of webDEALER.

### **Enhancements in Release 23.3**

## Ability for County to Designate when a Dealer Deputy can Print Registration Sticker Receipts

Currently, a dealer set up with license plate and sticker inventory can print a receipt with a sticker at the time of submission of the title application and at time of approval.

A county can now configure a dealer to only print sticker receipts at time of approval:

- 1. Go to Entities → Dealer Management
- 2. Select a Dealer name
- 3. Under Account Details for that dealer go to "Configure"
- 4. Select the appropriate radio button for "Issue Registration Stickers in Approved Status Only"







If a dealer is set to only print sticker receipts in an Approved status and attempts to print the receipt in another status, the receipt will not contain the sticker. The Sticker Print column will be ---.

Stickers will print with the receipt when the title application is in APPROVED status. The Sticker Print count will display a number if the sticker receipt has been printed. A limit of two prints is still the max limit per transaction. If sticker print is --- or 2 the receipt will print without the sticker.

## Ability for County to Authorize a Dealer Deputy to issue Standard Exempt License Plates

The County can now authorize a Dealer Deputy to issue Standard Exempt Inventory under the dealer's Account Details page, which will provide the dealer the ability to create standard and regular exempt title transactions.

A new **Exempt** checkbox will be enabled on the Owner Information page when a Dealer Deputy has appropriate inventory.

#### Allow Dealer to Locate DMV Rejected Transactions

In webDEALER, a dealer can now locate transactions that are DMV Rejected from the Title Search page by selecting the Approve status, checking the **DMV Rejected Only** checkbox and selecting Search.
