## About the Release

These Release Notes contain information about new features, enhancements, and reported issues resolved in this release of the Registration and Title System Point of Sale (RTS POS).

## RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.

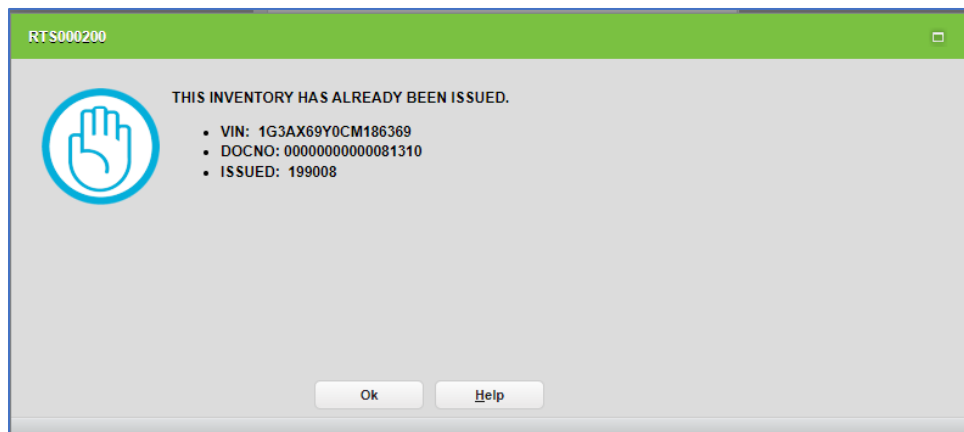
## Enhancements in RTS POS 24.1

### RRTS-32512 Prevent Issuance of Duplicate General Issue Plate Validation against Core

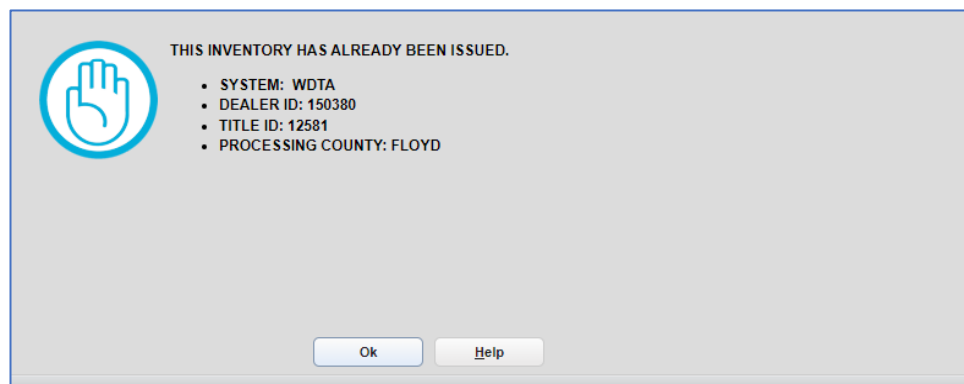
When processing a transaction and users enter a plate number, the system will validate the plate number to ensure that duplicate plate numbers are not being reissued. If a plate number has been issued in the system, users will be presented with one of the following error messages. Transactions will not be able to be completed until a new plate number is assigned.

If the inventory has been issued or is on hold in a transaction the below error message will display.

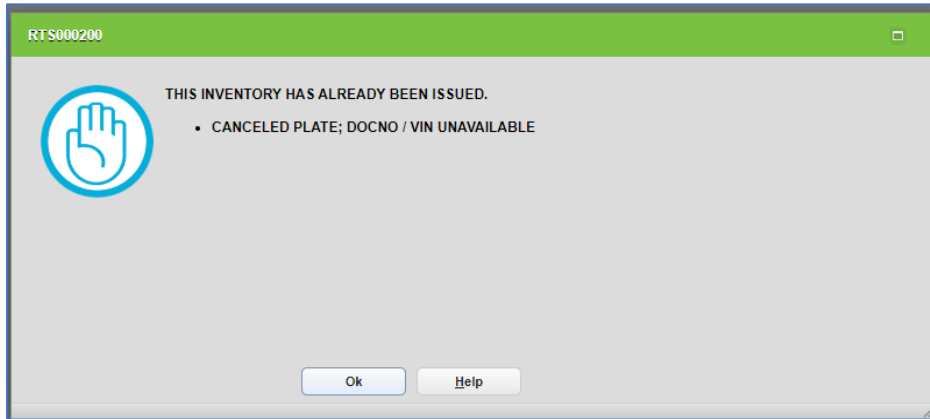
**NOTE:** The error message will contain variations of the VIN, DOCNO and ISSUED date, determined by the information available on the motor vehicle record.



If the inventory is found in a webDEALER transaction the following error message will display:

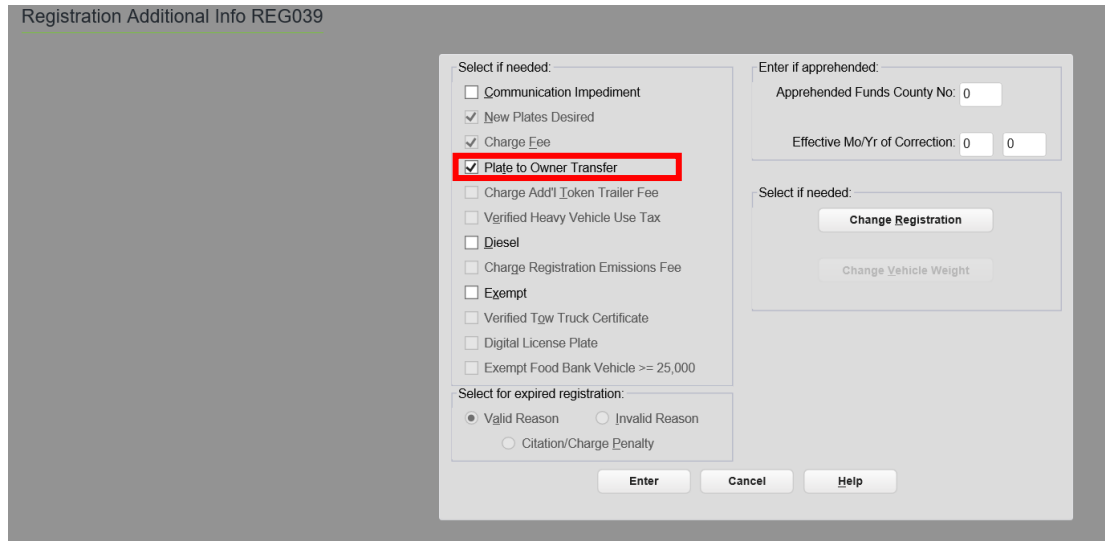


If the inventory is cancelled the following error message will display:



If an owner wants to transfer eligible license plates, the transfer should be allowed as long as the county tax assessor-collector's office can confirm the name on the vehicle record matches the name of the individual requesting to transfer the license plates. If the vehicle record has already changed, transfer may still be allowed if the individual can provide a prior registration receipt in their name.

On the **Registration Additional Info REG039** or **Title Additional Info TTL008** screens, utilize the **Plate to Owner Transfer** checkbox.



RRTS-33739	<p data-bbox="381 426 1299 489"><b>Reuse of inventory associated with Rejected Title or Rejected Transaction</b></p> <p data-bbox="381 516 1421 579"><b>Previously:</b> Users were not allowed to reissue the plate inventory and would result in an error message.</p> <p data-bbox="381 606 1458 705"><b>Change:</b> With this implementation, in RTS POS when plate inventory is associated with a transaction or title that has been rejected users will be able to reissue the plate.</p>
