## RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.






**RTS to allow an exchange from a Machinery Plate to a Frac Tank Plate.**

The new non-expiring Frac Tank plate is now available via the exchange process in RTS. The exchange will be allowed even if the Machinery plate has expired registration. A fee of \$5 will be charged for the new Frac Tank license plate. No partial credits will be given for any remaining registration on the Machinery plate.

**Completing the exchange is RTS as follows:**

Select Customer > Special Plates > Application. Select **No Vehicle** and Select Enter on the Inquiry Key Selection KEY001 screen.


