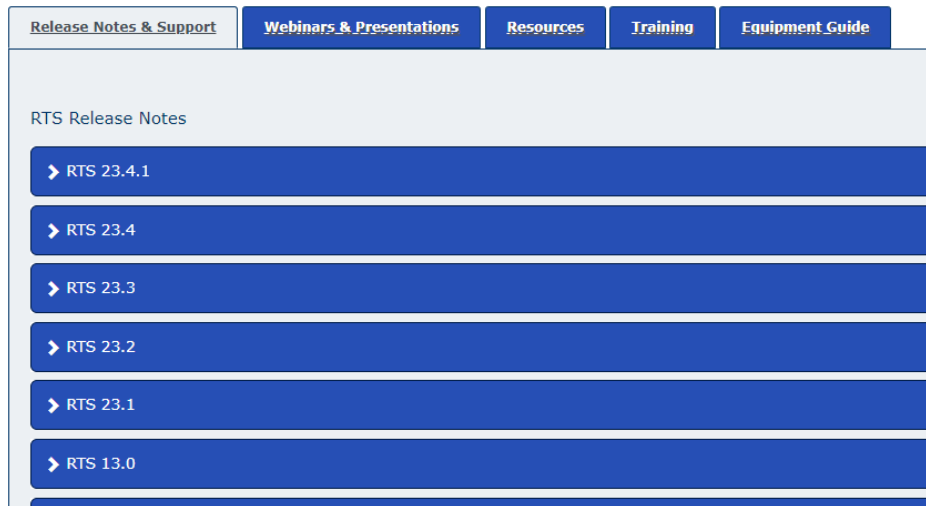

These Release Notes contain information about new features, enhancements, and reported issues resolved in this release of the Registration and Title System Point of Sale (RTS POS).

RTS POS Overview

The refactored RTS POS is a web-based application designed to process vehicle registrations, titles, and temporary permits for Texas motorists. RTS POS provides functions for cash accounting, funds allocations, and a full audit trail along with inventory control for license plates, windshield/plate stickers, and temporary permits.

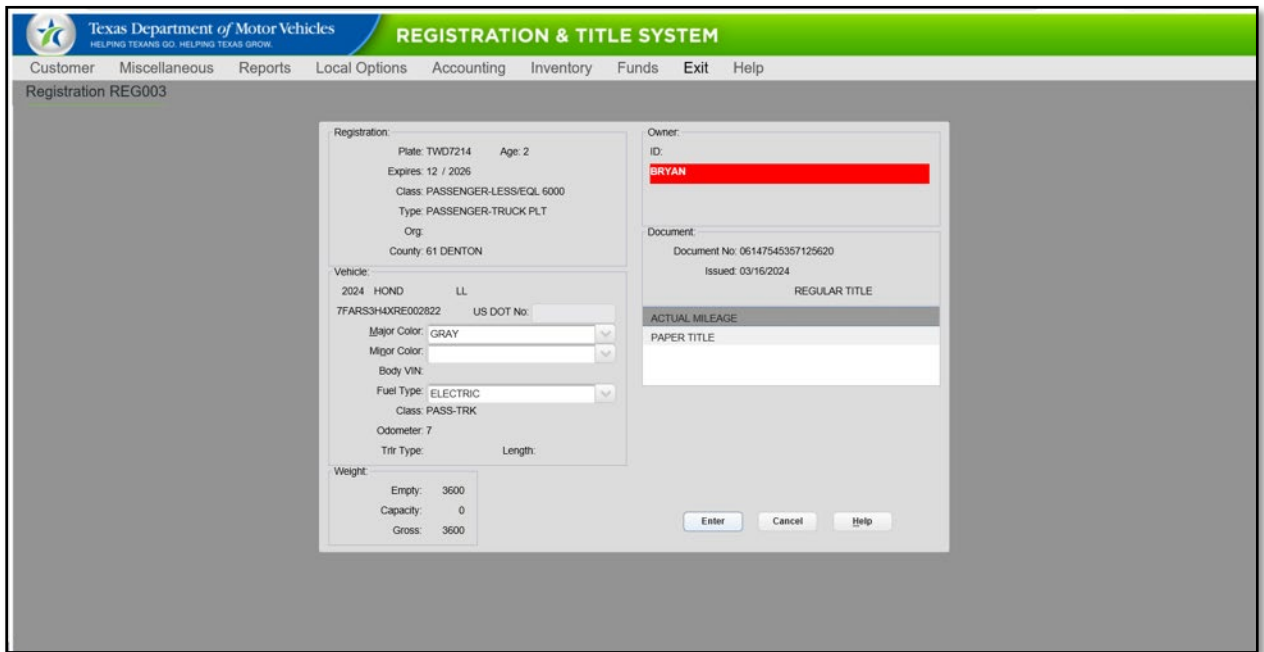

On the **Registration REG003** screen, verify that the record displayed is the record to which the credit should be applied and click the Enter button.

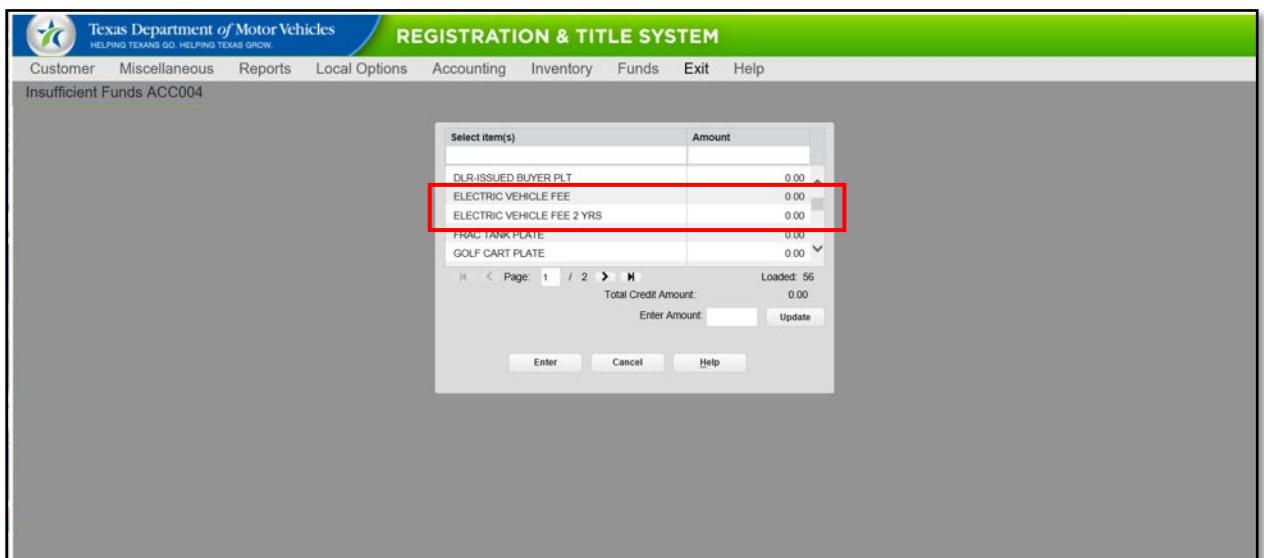

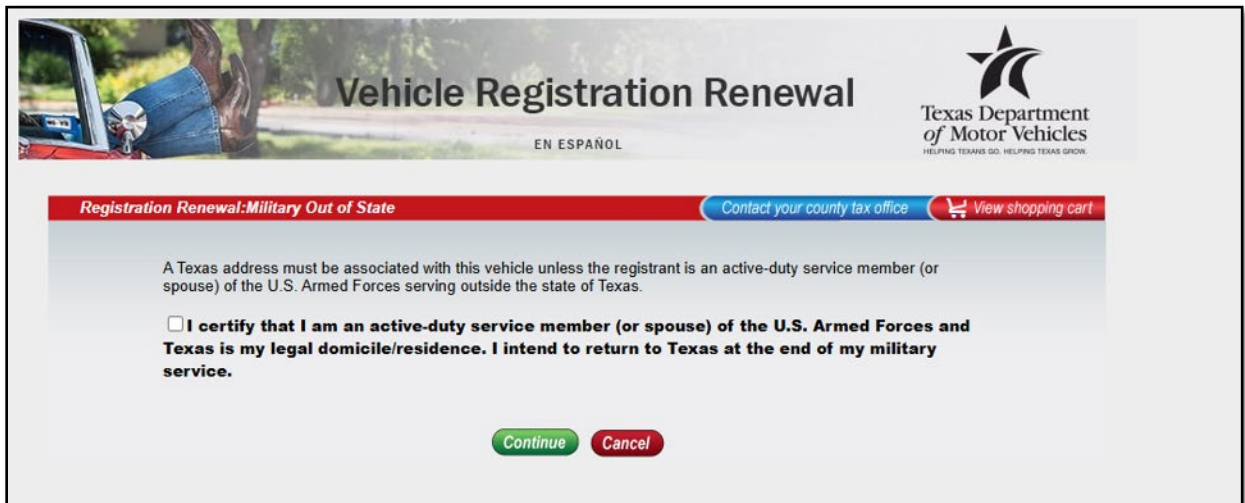

IVTRS: Online Registration Renewal for Active-Duty Military Service Members (or Spouses) without a Texas Address

Effective February of 2026, active-duty military service members (or spouses) serving outside of Texas, but claiming Texas as their legal domicile/residence, can register or renew their Texas vehicle registration without providing a physical address in Texas.

IVTRS has been updated to allow for the presentation and use of attestation functionality for active military members (or spouses) to complete an online transaction without a Texas address associated with the vehicle record. The attestation is presented after the entry of address information is provided at the time of online renewal. The attestation statement and information are provided in both English and Spanish.



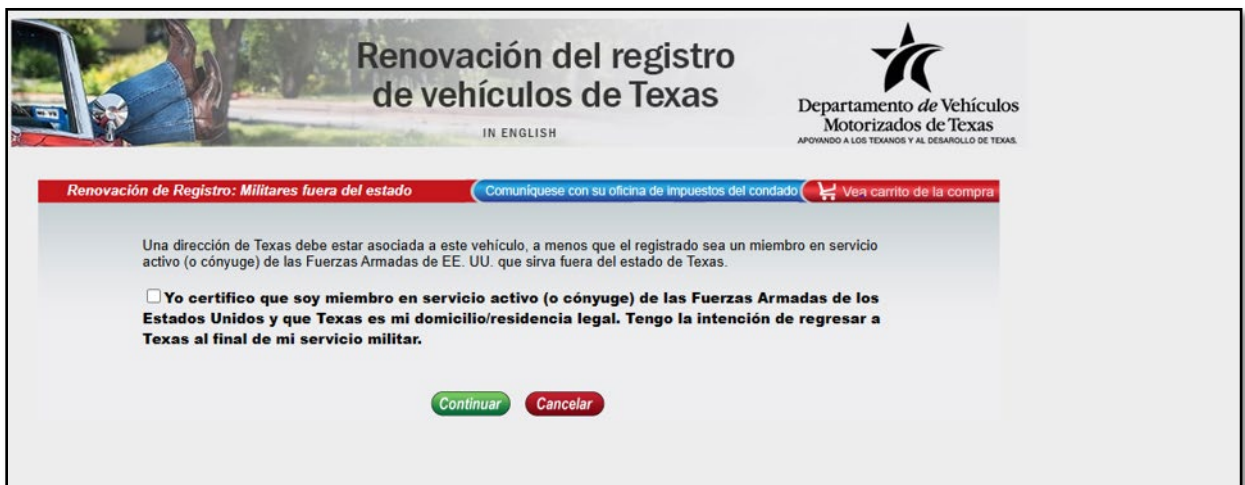

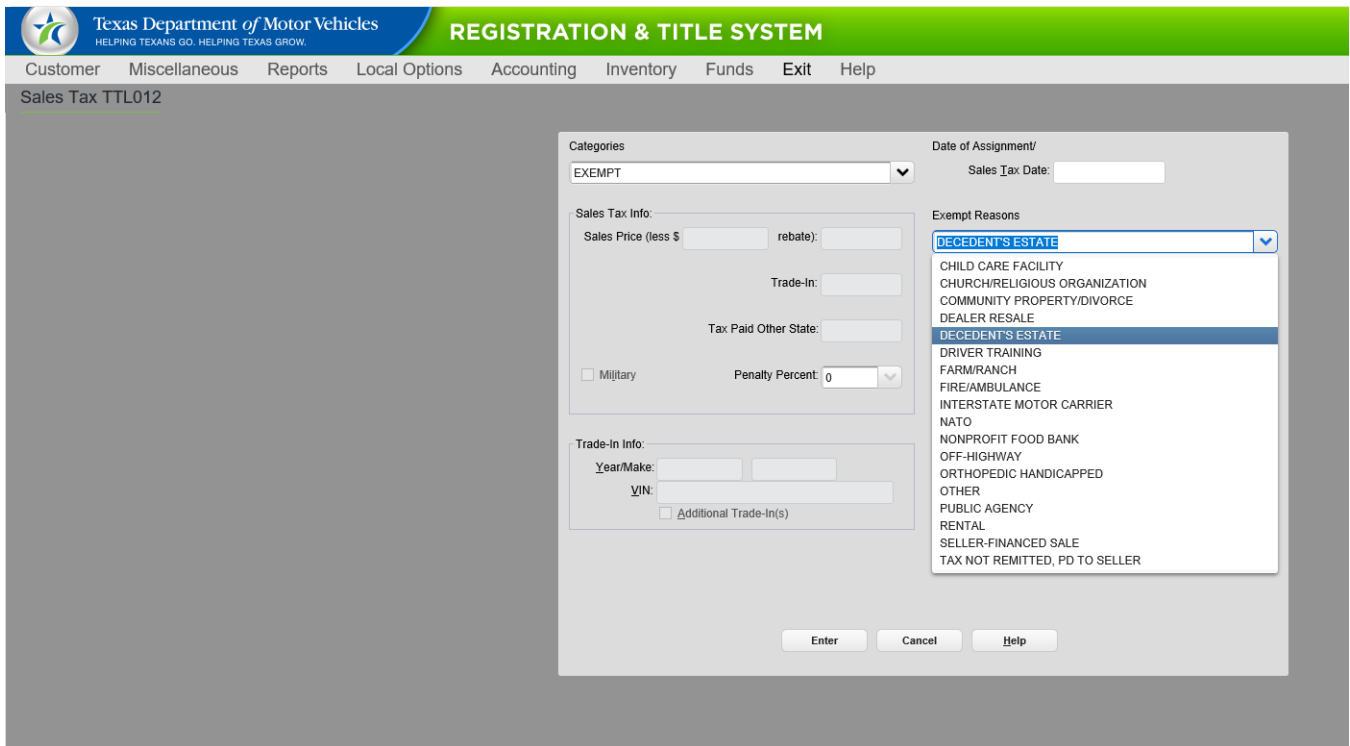

Bexar County added to list of emissions counties

Bexar County was added to the list of emissions counties and RTS was updated to require the collection of the emissions inspection fee beginning on November 1, 2026. Registration processed prior to the effective date of November 1, 2026, will not require an emissions inspection and will not be charged the emissions inspection fee, regardless of the registration expiration date.

As currently programmed for the existing 17 emissions counties, if an emissions inspection is found the system will charge the appropriate \$2.75 Emissions Inspection Fee. If an inspection is not found, the system will provide an option to manually verify the inspection. Exempt From Emissions options remain as previously programmed.

Vehicle Registration Renewal Notices (Paper and Electronic)

Bexar County residents with November 2026 expirations will start seeing emissions messaging on renewal notices that are distributed in September of 2026. If the vehicle is exempt from an emissions inspection, the EMISSIONS INSPECTION FEE will not be charged.

Effective January 1st, 2025, you are not required to obtain a vehicle safety inspection prior to registering your vehicle. You will be assessed the Inspection Replacement Fee shown below. The Inspection Replacement Fee replaces the previous safety inspection fee.

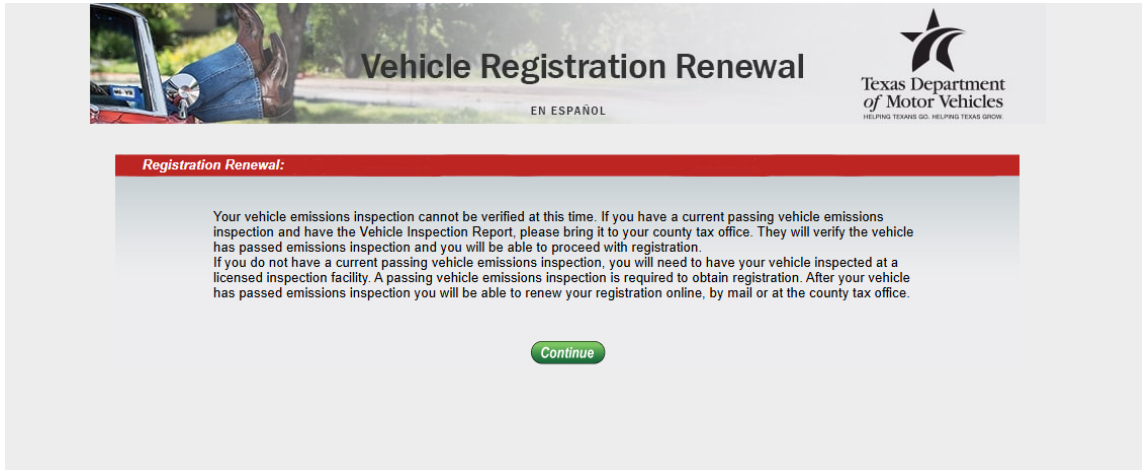

Registration Renewal: Affidavit Exempt Reasons

- ☐ Is your vehicle out of state? You must complete a Texas emissions inspection upon returning to Texas. A remark will be placed on your vehicle record indicating an emissions inspection is still due. Law enforcement will not be able to electronically verify your emissions inspection. You will need to retain your vehicle inspection report to show to law enforcement because the remark will not be removed at the time of emissions inspection. I certify that I am entitled to continue to renew my Texas registration and the vehicle is out of state and unable to complete the required emissions inspection. I understand I must obtain a passing Texas emissions inspection when the vehicle returns to Texas. I understand that a remark will be placed on my vehicle record informing law enforcement to verify my vehicles emissions inspection status.
- ☐ Vehicle is not subject to the Texas Vehicle Emissions Inspection and Maintenance Program because said vehicle is not and will not be primarily operated (driven, parked, or stored for 60 calendar days per testing cycle) in affected counties. I further certify that in the future if said vehicle is primarily operated in affected counties, said vehicle will be reinspected at an inspection station certified to do emissions testing. (Registered in an affected county, but operated outside an affected county, e.g., company fleet vehicle, hunting vehicle, exempt from emission test on resale, etc.)
- ☐ Vehicle is no longer subject to the Texas Vehicle Emissions Inspection and Maintenance Program because said vehicle is no longer and will no longer be primarily operated (driven, parked, or stored for 60 calendar days per testing cycle) in affected counties. I further certify that in the future if said vehicle is primarily operated in affected counties, said vehicle will be reinspected at an inspection station certified to do emissions testing. (Registered in an affected county, but owner does not currently reside in an affected county and will not operate over 60 days per calendar year in an affected county, e.g., someone who moved from an affected county)

If the customer selects None of These Apply, the system will provide a message indicating that an emissions inspection cannot be verified. Customers will be instructed to either visit their county tax office with their Vehicle Inspection Report or obtain a passing emissions inspection.
