### INSTRUCTIONS FOR IRREVOCABLE STANDBY LETTER OF CREDIT

These instructions apply when a letter of credit (LOC) on Texas Department of Motor Vehicles form number MCD-LOC01, "Irrevocable Standby Letter of Credit," is being issued to the County Commissioners Court of any county in the state of Texas as beneficiary and as a requirement for the issuance of over axle/over gross weight tolerance and timber permit(s). The issuing Bank shall not alter the text of the form LOC in any way. These instructions do not form part of the LOC issued on the form.

Information on the following items should be supplied as follows:

Beneficiary	The Beneficiary of the LOC shall be:			
	County Commissioners Court of any county in the state of Texas			
Customer/Principal	The exact name of the entity that is a customer to the Beneficiary and for whose obligations to the Beneficiary this LOC is intended to serve as collateral.			
Issuing bank	LOC will only be accepted from banks that are subject to the laws of Texas.			
Effective date	The effective date shall be on or before the date on which a permit is to be issued against an LOC.			
Authorized signature	An original signature of an officer/representative of the issuing bank.
